preparing for comprehensive plan update, working with CoPA and CoS through JSWAB to update Interlocal Agreement (ILA), Environmental Health developing GIS recycling resource, Still have vacancies on SWAC that need to be filled
- City of Port Angeles:

Working through JSWAB to update ILA, Rally-in-the-Alley event held last month (Joint effort with Waste Connections, CoS and Habitat for Humanity), Used oil collection discontinued at CoS maintenance facility (Blue Mountain Transfer Station, Regional Transfer Station and private collection still available)
- Waste Connections:
AI recycling contamination cameras fitted on some trucks, and the system generates a letter to inform customers about contamination in recycling. Subscription lasts through 2026. Tracks changes in recycling contamination
- Makah Tribe:
Completed their solid waste management plan in July 2025.
