

## **NOTICE OF GENERAL ELECTION**

**Clallam County, State of Washington**

**NOTICE IS HEREBY GIVEN**, that on Tuesday, the 8<sup>th</sup> day of November 2022, a General Election will be conducted entirely by mail in Clallam County. Ballots for this election will be mailed to all qualified voters on October 19, 2022. The purpose of this election is to approve or to reject State Advisory Votes and to elect officials to various offices.

**VOTER REGISTRATION DEADLINES:** Pursuant to RCW 29A.08.140, the registration deadlines for all precincts within the districts voting in the General will be as follows:

**ONLINE OR BY MAIL:** Last day to register or update registration is October 31, 2022 (Registrations must be *received* by the Elections and Voter Registration Office). Printable voter registration forms can be found online at [www.clallam.net/elections](http://www.clallam.net/elections). You can also register using the online portal at [www.votewa.gov](http://www.votewa.gov).

**IN-PERSON:** Last day to register or update registration at the Election and Voter Registration Office is November 8, 2022. You may register to vote or update your registration at the Elections and Voter Registration Office, 223 E 4<sup>th</sup> St, Basement Floor, Room 042 in Port Angeles between 9:30 a.m. and 4:30 p.m., Monday through Friday. On Election Day, November 8, we are open until 8:00 p.m.

A registered voter who fails to transfer their residential address by these deadlines may vote according to their previous registration address.

**VOTING AID:** To assist elderly and disabled persons in voting their ballot, an Accessible Voting Unit is available in the Elections and Voter Registration Office, Room 042, beginning October 19, 2022, during business hours and until 8:00 p.m. on Election Day.

**OPEN PUBLIC MEETING NOTICE:** The Canvassing Board of Clallam County, pursuant to chapter 29A.60 RCW, will hold public meetings on the following dates and times:

- Canvassing Board Meeting – Precertification – November 28, 2022, at 1:00 p.m.
