

How to Vote




Use a **dark colored pen** to completely fill in the oval to the left of your choice.

Vote for ONLY one in each contest.

If you vote for more than one choice, your vote will not count for that race or measure.

How to Correct a Vote



To make a correction, draw a line through the entire incorrect choice. You then have the option of making another choice.

Optional Write-in

To vote for a write-in candidate, fill in the oval next to the write-in line and print the name.

Returning Your Ballot

By Mail: Ballots must be post-marked on or before Election Day to be counted.
By Official Ballot Drop Box: Ballots must be deposited inside an Official Ballot Drop Box by 8:00 p.m. on Election Night to be counted. *See insert for details.*

If a primary election was held for an office, the two candidates who received the most votes in the Primary advance to the General Election.

READ: Each candidate for partisan office may state a political party that he or she prefers. A candidate's preference does not imply that the candidate is nominated or endorsed by the party, or that the party approves of or associates with that candidate.
