

NOTICE OF SPECIAL ELECTION

NOTICE IS HEREBY GIVEN, that on Tuesday, the 23rd of April 2024, a Special Election will be conducted entirely by mail for one fire protection district in Clallam County. The purpose of this election is to approve and adopt or to reject local propositions. Ballots for this election will be mailed to all qualified voters on April 3, 2024.

Below are the local propositions, which will appear on the ballot:

VOTER REGISTRATION DEADLINES: Pursuant to RCW 29A.08.140, the registration deadlines for all precincts within the districts voting in the Special Election will be as follows:

Online or by mail: Last day to register or update registration online or by mail is April 15, 2024 (Registrations must be received by the Auditor's Office by this date). Printable voter registration forms can be found online at www.clallamcountywa.gov/elections. You can also register using the online portal at www.votewa.gov.

In-person: Last day to register or update registration in person is April 23, 2024. You may register to vote or update your registration at the Clallam County Elections and Voter Registration Office, located on the lower level of the Clallam County Courthouse, 223 E 4th St, Room 042, Port Angeles, WA. Office hours are 8:00 a.m. to 4:30 p.m. (closed 12:30-1:30) Monday through Friday. On Election Day, April 23, 2024, we are open until 8:00 p.m.

A registered voter who fails to transfer his or her residential address by these deadlines may vote according to his/her previous registration address.

VOTING AID: To assist the elderly and voters with disabilities in voting their ballot, an Accessible Voting Unit is available in the Elections and Voter Registration Office beginning April 3, 2024, through 8:00 p.m. on Election Day.

OPEN PUBLIC MEETING NOTICE: The Canvassing Board of Clallam County, pursuant to chapter 29A.60 RCW, will hold public meetings on the following dates and times:

Thursday, May 2, 2024, at 1:00 p.m. and Friday, May 3, 2024, at 2:00 p.m., at the Clallam County Courthouse, 223 E 4th St, in the Elections Center, Room 072, to conduct the canvassing and certification of votes cast in the Election.
