Notice of General Election

NOTICE IS HEREBY GIVEN, that on Tuesday, November 5, 2024, a General Election will be conducted entirely by mail for all of Clallam County. The purpose of this General Election is to approve or reject State Measures, Local Propositions, and to elect officials to County, State and Federal positions.

Ballots for this General Election will be mailed to all qualified voters on October 16, 2024.

VOTER REGISTRATION DEADLINES: Pursuant to RCW 29A.08.140, the registration deadlines for all precincts within the districts voting in the General Election will be as follows:

Online or by mail: Last day to register or update registration online or by mail is October 28, 2024 (Registrations must be received by the Auditor's Office by this date). Printable voter registration forms can be found online at www.clallamcountywa.gov/elections. You can also register using the online portal at www.votewa.gov.

In-person: Last day to register or update registration in person is November 5, 2024. You may register to vote or update your registration at the Clallam County Elections and Voter Registration Office, located on the lower level of the Clallam County Courthouse, 223 E 4th St, Room 042, Port Angeles, WA. Office hours are 8:00 AM to 4:30 PM Monday through Friday. On Election Day, November 5, 2024, we are open until 8:00 PM.

A registered voter who fails to transfer his or her residential address by these deadlines may vote according to his/her previous registration address.

VOTING AID: To assist the elderly and voters with disabilities in voting their ballot, an Accessible Voting Unit is available in the Elections and Voter Registration Office beginning October 16, 2024, through 8:00 PM on Election Day.

OPEN PUBLIC MEETING NOTICE: The Canvassing Board of Clallam County, pursuant to chapter 29A.60 RCW, will hold public meetings on the following dates and times:

Friday, November 22, 2024, at 1:00 PM; Monday, November 25, 2024, at 1:00 PM; and Tuesday, November 26, 2024, at 2:00 PM, at the Clallam County Courthouse, 223 E 4th St, Room 160, in the Board of Commissioners Meeting Room, to conduct the canvassing and certification of votes cast in the General Election.
