Notice of Special Election

NOTICE IS HEREBY GIVEN, that on Tuesday, February 11, 2025, a Special Election will be conducted entirely by mail for the Sequim and Quillayute Valley School Districts. The purpose of this Special Election is to approve and adopt or to reject local ballot propositions.

Ballots for this Special Election will be mailed to all qualified voters on January 22, 2025.

VOTER REGISTRATION DEADLINES: Pursuant to RCW 29A.08.140, the registration deadlines for all precincts within the districts voting in the Special Election will be as follows:

Online or by mail: Last day to register or update registration online or by mail is February 3, 2025 (Registrations must be received by the Auditor's Office by this date). Printable voter registration forms can be found online at www.clallamcountywa.gov/elections. You can also register using the online portal at www.votewa.gov.

In-person: Last day to register or update registration in person is February 11, 2025. You may register to vote or update your registration at the Clallam County Elections and Voter Registration Office, located on the lower level of the Clallam County Courthouse, 223 E 4th St, Room 042, Port Angeles, WA. Office hours are 8:00 AM to 4:30 PM Monday through Friday. On Election Day, February 11, 2025, we are open until 8:00 PM.

A registered voter who fails to transfer his or her residential address by these deadlines may vote according to his/her previous registration address.

VOTING AID: To assist the elderly and voters with disabilities in voting their ballot, an Accessible Voting Unit is available in the Elections and Voter Registration Office beginning January 22, 2025, through 8:00 PM on Election Day.

OPEN PUBLIC MEETING NOTICE: The Canvassing Board of Clallam County, pursuant to chapter 29A.60 RCW, will hold public meetings on the following dates and times:

Thursday, February 20, 2025, at 1:00 PM; and Friday, February 21, 2025, at 2:00 PM, in the Elections Center of the Clallam County Courthouse, 223 E 4th St, Room 072, Port Angeles, WA, to conduct the canvassing and certification of votes cast in the Special Election.
