

Notice of Primary

NOTICE IS HEREBY GIVEN, that on Tuesday, August 5, 2025, a Primary will be conducted entirely by mail for Hospital District 2, City of Port Angeles, Port Angeles School District 121, and Fire District 3 in Clallam County. The purpose of this Primary is to nominate the top 2 candidates from each contest for the General Election, and to approve and adopt or to reject local ballot propositions.

Ballots for this Primary will be mailed to all qualified voters on Wednesday, July 16, 2025.

VOTER REGISTRATION DEADLINES: Pursuant to RCW 29A.08.140, the registration deadlines for all precincts within the districts voting in the Primary will be as follows:

Online or by mail: Last day to register or update registration online or by mail is July 28, 2025 (registrations must be received by the Auditor's Office by this date). Printable voter registration forms can be found online at www.clallamcountywa.gov/elections. You can also register using the online portal at www.VoteWA.gov.

In-person: Last day to register or update your registration in person is August 5, 2025. You may register to vote or update your registration at the Clallam County Elections and Voter Registration Office, located on the lower level of the Clallam County Courthouse, 223 E 4th St, Room 042, Port Angeles, WA. Office hours are 8:00 AM to 4:30 PM Monday through Friday. On Election Day, August 5, 2025, we are open until 8:00 PM.

A registered voter who fails to transfer their residential address by these deadlines may vote according to their previous registration address.

VOTING AID: To assist the elderly and voters with disabilities in voting their ballot, an Accessible Voting Unit is available in the Elections and Voter Registration Office beginning July 16, 2025, through 8:00 PM on Election Day.

OPEN PUBLIC MEETING NOTICE: The Canvassing Board of Clallam County, pursuant to chapter 29A.60 RCW, will hold public meetings on the following dates and times:

Monday, August 18, 2025, at 1:00 PM; and Tuesday, August 19, 2025, at 2:00 PM, at the Clallam County Courthouse, 223 E 4th St, Room 072, in the Elections Center on the lower level, to conduct the canvassing and certification of votes cast in the Primary.
