Clallam County On-Site Septic - 2024 to 2026


Individualized chart showing the amounts levied or billed each year over (3) years.













Weed and Fire Patrol Assessments - 2024 to 2026

The Weed Assessment funds the weed control program; all landowners, both public and private must contribute to this fund.

Fire Patrol fees are assessed by the Department of Natural Resources on qualifying parcels, to assist with the management of forest fires.

The Fire Patrol LCFESA is a 're-coup' fee designed to capture funds that the State of Washington under collected in regard to Fire Patrol fees for prior years. This is a temporary assessment.

Conservation District - 2024 to 2026


Individualized chart showing the amounts levied or billed each year over (3) years.
