Agreement between  
The City of Forks  
And  
Clallam County  
to amend the existing Interlocal Agreement  
Establishing District Court Filing Fees

Whereas, the City of Forks and the Board of Commissioners of Clallam County have benefited from an existing legal agreement between the parties regarding the establishment of District Court II filing fees;

Whereas, that previous agreement was created in 2006 and has been updated at various times since then, but neither party has not been able to locate the amendment that would apply to 2020;

Whereas the parties believe it is in the best interests of the citizens of the Westend of Clallam County to continue that relationship and clearly establish fees in a readily findable document;

NOW, THEREFORE THE CITY OF FORKS AND THE BOARD OF COMMISSIONERS  
HEREBY AGREE AS FOLLOWS:

1. The Interlocal Agreement Establishing District Court Filing Fees for the City of Forks (Agreement), incorporated by reference as if fully set forth, between the City and the County shall be amended as follows:
  - a. Filing Fees for 2020 shall be as followed, hereby amending Paragraph 2.1 of the Agreement:  
  
    Infractions:     \$28 (Twenty-eight dollars)  
    Criminal:       \$85 (Eight-five dollars)
  - b. The Agreement's paragraph 2.3 is amended and replaced as follows:  
  
    Adjustments for Inflation: For the subsequent years of this agreement, the previous year's fees shall be increased annually there after for inflation based upon the August to August Seattle CPI-W Index. However, the annual increase shall not be greater than 5.0%. In all cases, the adjusted amount will be rounded to the nearest dollar.
  - c. Duration of the Agreement shall be amended to read as follows:  
  
    This Agreement shall be in effect for a term of five years commencing on 1 January 2020 and ending on 31 December 2024. The Agreement shall remain in effect, until rescinded or terminated by the parties, thereafter with the parties agreeing that any filing fee rate for subsequent years will be determined by the parties prior to 31 December.

Either party may terminate this agreement upon giving the other party 90 days' notice.

2. The Board of Commissioners agree to ensure that a copy of this agreement is filed with the County Auditor's Office and the Secretary of State pursuant to applicable state law.


