**SCOPE OF WORK**

In partial fulfillment of Washington Department of Wildlife contract 09-1514, Amendment No.2: July 1, 2010 - June 30, 2011.

AND in accordance with the Interlocal Cooperation Act (Chapter 39.34 RCW) that provides authority for governmental entities to exercise their respective powers jointly through intergovernmental agreements,

AND in accordance with the fourth clause in the ORIGINAL INTERLOCAL AGREEMENT, "*This agreement may be amended by the mutual written agreement of both parties. The basis for amending or terminating this agreement may be an increase or decrease in project funding, addition of required tasks not addressed in this agreement, or other items affecting the planning process required under Chapter 36.125 RCW*" the AGREEMENT is hereby amended as follows:

The second clause in the ORIGINAL INTERLOCAL AGREEMENT shall read "*Clallam County will compensate Jefferson County an amount not to exceed the total sum of \$22,200 for the activities and products detailed in Exhibit A and the extended Exhibit A tasks listed below.*"

Aside from this change, there are no other modifications to the ORIGINAL AGREEMENT.

Extended Exhibit A Tasks under this amendment:

**Task 1:** MRC Coordination. Clallam County will provide MRC Coordinator support including planning and organizing meetings, leading/facilitating meetings, and recording and distributing meeting and activity summaries to those interested in MRC activities. In coordination with Jefferson County Environmental Health Staff, the MRC Coordinator will maintain and develop additional outreach tools as a means to communicate to the Marine Resource Committee and the public regarding activities and accomplishments **(\$2,000)**.

Deliverable 1g (Jefferson): Maintain Jefferson County presence at MRC meetings and related events **(\$3,000)**.

**Task 2:** Two-County Partnership. Continue the formal Inter-local Agreement (ILA) for the two-county partnership for a "West End" MRC.

Deliverable 2a: ILA signed by Jefferson and Clallam Counties. (Due January 1, 2011) **(\$500)**.

**Task 3:** MRC Outreach (Clallam and Jefferson). Continue publication of the West End MRC Newsletter.

Deliverable 3a: Production and distribution of the semi-annual printed edition of the West End MRC Newsletter. (Due June 30, 2011) **(\$3,000)**.

Deliverable 3b: Monthly production of the Email Newsletter NPC MRC News including meeting summaries. Due June 30, 2011) **(\$2,500)**.
