Olympic Medical Center
Property Tax Levy
The Commission of Public Hospital District No. 2 adopted Resolution No. 416 concerning a proposition to increase its regular property tax levy. If approved, this proposition would authorize the District to increase its regular property levy rate from its current level to a rate of 44 cents per \$1,000 of assessed value for collection in 2009, which amount will be used for computing legal limits on levies in subsequent years, to provide funding for emergency, hospital and other health care services and facilities for the benefit of District residents.
