



**About the Map**

The information depicted on this map is intended to be used with the Shoreline Master Program (SMP). The shoreline environmental designation and jurisdictional boundaries shown are based on the approximate location of the ordinary high water mark, 100-year floodplain, and associated wetlands. The maps are intended for planning purposes only and do not identify or depict the precise lateral extent of shoreline jurisdiction or the location of all associated wetlands and critical areas regulated by the SMP. Interpretation of the maps requires professional judgment and site-specific information as to the actual physical location of shoreline jurisdiction, floodplains, wetlands, critical areas, and other such features. The designations assigned to each shoreline reach shall apply throughout the full jurisdictional limits set forth by the SMP, as determined on a parcel-by-parcel basis at the time a shoreline use/development is proposed. In the event of a mapping error or discrepancy, the text of the SMP and applicable authority of RCW 90.58 and WAC 173-26 shall prevail.
