### Be aware, it typically takes one or more treatments per year over 3-5 years to fully eradicate a Noxious Weed infestation

Things to consider when hiring a contractor: Is there a contract or assurance of effectiveness? Does the contractor know how to accurately identify the plant?

Is the herbicide being used appropriate for the plants and site being treated? Is it the appropriate time of year to treat? Contact the NWCB if you have questions.
