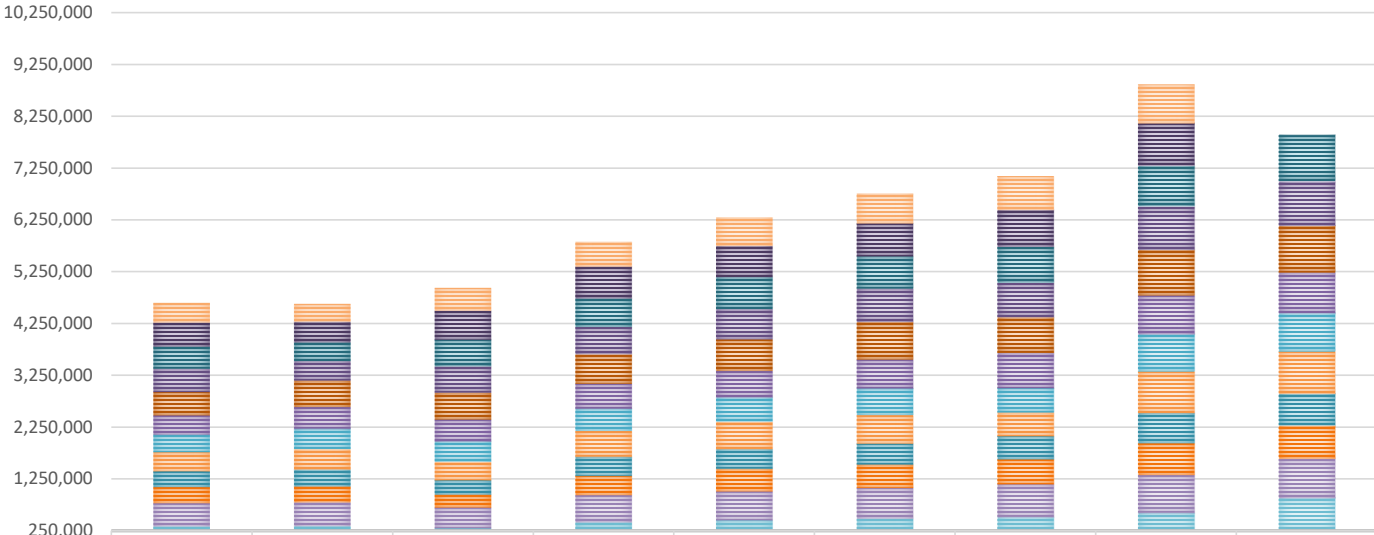
STATE OF WASHINGTON PORTION REAL ESTATE EXCISE TAX



CLALLAM COUNTY PORTION REAL ESTATE EXCISE TAX

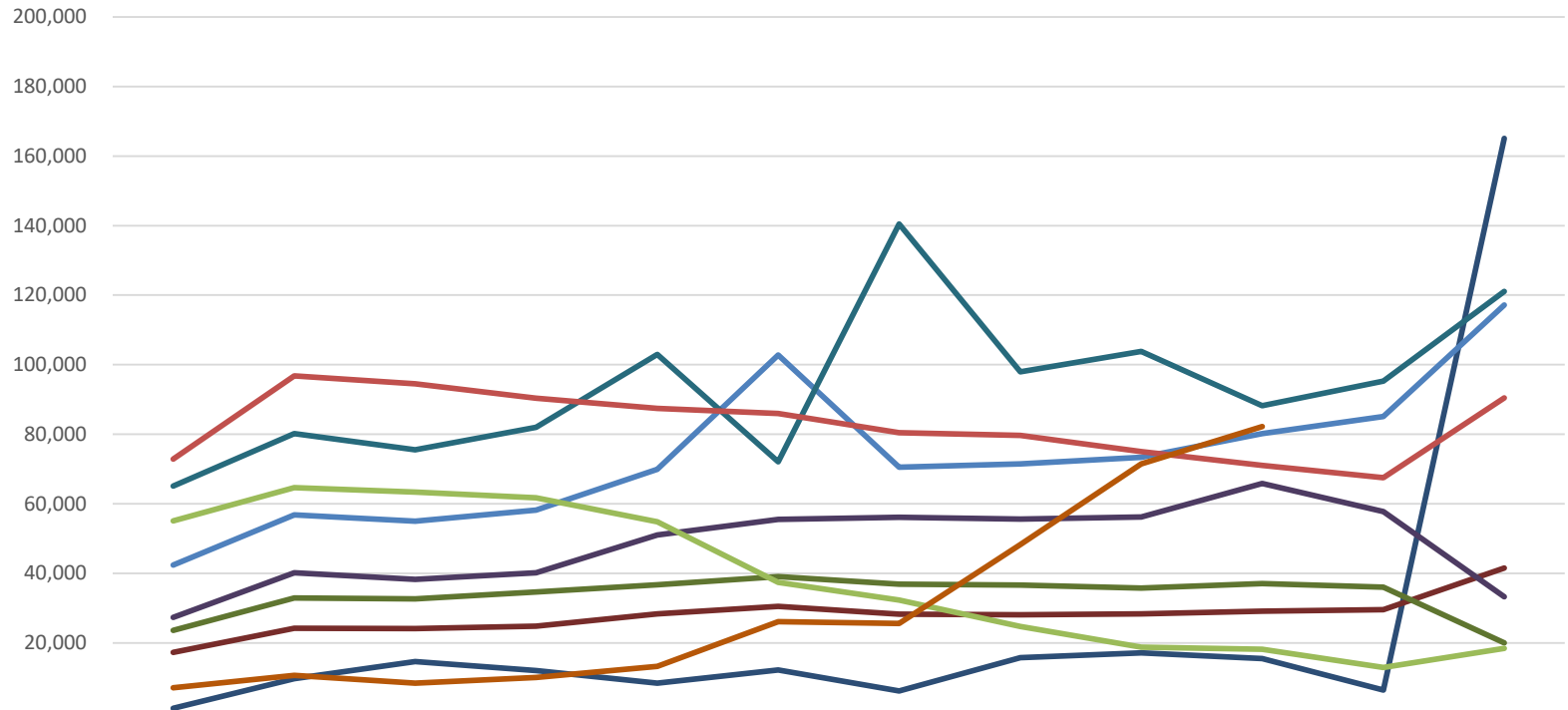


CLALLAM COUNTY SALES/USE TAX REVENUE
